1. The participant is an experienced player of the game of rugby football and/or flag rugby, and is familiar with the laws of the game.

2. The participant is aware that playing rugby may result in injuries and that participant's expose themselves to the risk of bodily injury or death through their participation in the game.

3. The participant wishes to participate in the play of rugby during the Lakefront 7s Rugby Tournament at Veterans Park, Milwaukee, WI.

4. The participant agrees to waive any claim for damage, injury, or death arising out of this participation in the Lakefront 7s Rugby Tournament.

6. The participant agrees that this waiver shall be binding upon the undersigned, his/hers representatives, heirs and assigns forever.

7. The participant assumes all risks of damage, injury, or contracting infectious disease (such as MRSA, influenza and COVID-19) resulting from participation in the Lakefront 7s Rugby Tournament in accordance with the comparative negligence provisions under the Laws of the State of Wisconsin.
